<u>JANUARY BOARD REPORT</u>: The Board approved the budgeted club charities as follows: LCIF \$1,000; Pilot Dogs \$500; Ohio Sight/Hearing \$200; Ohio Lions Foundation \$400; Ohio Diabetes Fund \$250; Ohio Lions Eye Research \$100; NW Ohio Eyecare \$250; Lions International Relations \$100; Bluffton Public Library \$500; Bluffton Community Assistance \$100; Mennonite Memorial Home \$500. The Citizen of the Year celebration will be on April 6th to be held at the Bluffton University. A pancake breakfast will be held in March at the Bluffton Middle School. Date to be determined. Scholarship applications provided to the three local schools.

Discussion followed on the Foundation By-Law Amendments that will be discussed at the foundation meeting and a special meeting of the club members will be called for a vote.

The following amendments will be voted upon on February 7th:

- l. Article IV Directors, Section l. Number. The Corporation shall have the same Directors as the Bluffton Lions Club, and be known as the Board of Directors.
- 2. Article V, Officers, Section 1. Designation of Officers. The Officers of the Corporation shall be a President, Vice Presidents, Secretary and Treasurer, and they shall be those individuals who hold the same offices in the Bluffton Lions Club.
- 3. Article V, Section 3. Officers shall be elected in the same manner as the officers of the Bluffton Lions Club, and their term shall be concurrent.
